## Visa information

In traveling to Bali and Costa Rica, contacting the embassies in one's home country for upto-date visa information is recommended, as visa regulations can change frequently. The visa application process varies from country to country and even from one official to another. It is advised that individuals take care of their visa well in advance before departing for the destination.

Stay updated on the latest updates regarding visa applications, required documents, and the embassy's operating hours by visiting their website or directly contacting the embassy. Embassies follow the public holidays of the country they represent as well as the host country's holidays. It is recommended to make copies of the passport and have electronic copies of important documents on a computer, email, and a USB stick for convenience and security.

## **Tourist Visa Waiver (COSTA RICA)**

Many nations including European citizens are entitled to travel to Costa Rica for 90 days as a tourist without a visa. This is recommended for students studying in Costa Rica for one semester, as it might take longer than six months to finalize the student visa procedure in Costa Rica.

The requirements and length of the tourist visa waiver depend on your nationality. For European citizens, a 90-days stay is being issued at any migratory post when entering the country, no previous requirement is needed. However, the immigration officer upon arrival will have the last word on the length of your tourist visa waiver. Because of this, please be polite to all officers when arriving in Costa Rica

At the end of 90 days, you must do e.g. a visa run and leave the country. Upon returning to Costa Rica, the permit will be renewed automatically for 90 more days. ULACIT is organizing tours that enable students to renew their visas on time. Students can also travel independently. For example, Panama, Nicaragua, and Mexico have been common countries to visit while getting a visa renewal.



## Visa Index B211A (Visit Stay Permit for single entry only)

Please check the latest updates about visa applications, required documents, fees, and opening hours on the embassy website or by calling the embassy directly. Embassies are open according to the public holidays of the country they represent, as well as the holidays of the country in which they are located

The name of the student visa you should apply for varies from one embassy to the other: It can be called Social Visit Visa, Socio-Cultural Visa, or Short Visit Visa.

Indonesian embassies grant these single-entry visas to conduct an exchange semester in Indonesia. (Short term 1-6 months)

The total length of stay in Indonesia with this type of visa is 180 days, which includes two time of extension)

This single entry is used when you enter Indonesia for the first time (i.e., you cannot exit Indonesia and re-enter after this with your original visa). These social visit visas are not usually available with multiple entries because this requires a separate document to be applied from the Directorate General of Immigration in Jakarta, Indonesia.
